The matter relating to colleges similarly placed were considered by the Legal Education Committee of Bar Council of India at it's meeting held on 30.4.2017 which was further ratified/confirmed by the General Council of Bar Council of India on 5th May, 2017. The resolution passed was as follows:

"RESOLVED that colleges whose inspection fee has been deposited, application for extension of approval of affiliation is pending, no inspection could be done or the inspection has been done, but inspection report could not be placed before the Legal Education Committee or the Standing Committee for its consideration, then such colleges may continue to admit students only for the academic year 2017-2018. This will apply only in case where affiliation has been granted by the University which of course shall be subject to the inspection to be made by the Bar Council of India subsequently."

Since your university has given affiliation for the year 2017-2018, you are requested to allow Pacific Academy of Higher Education & Research University, Debari, Udaipur, Rajasthan to admit students in three year LLB as well as five year BA.LLB and five year B.Com LLB law courses with existing sections for the academic year 2017-2018.
